- Complete and sign the E+ Residential Electric Existing Home application. Your contractor (or you if you are self-installing) must indicate the beginning and ending R-value and initial next to each completed job.
- 6. Attach originals or legible copies of the following:
 - Invoice from contractor or receipt for materials purchased.
 - Contractor invoice should include: invoice date; invoice number; name and address of contractor; address where work was performed; square footage insulated; R-value of insulation installed; and itemized cost of all installed materials.
 - Current NorthWestern Energy bill for address where insulation was installed.

NOTE: Rebate is paid to current account holder.

7. Submit completed application along with all documentation and current NorthWestern Energy bill.
